The repair service shall include all inspection, repairs, adjustment, restoration and re-placement of assemblies and components used to construct a complete vehicle.

The tender will cover the Kent, Surrey and Sussex Regions.

SECAmb is intending to issue an open tender early November 2025

Contract period will be for an initial 2 year period with 2 options to extend for 1 year (4 years total)

SECAmb is intending to appoint multiple providers to cover the geographic regions.
