NHS Devon ICB intends to award a contract for provision of 4 block booked beds in appropriate hospice accommodation, to support discharge from hospital for patients at end of life from University Hospital Plymouth who are unable, or do not wish, to return to their home address.

It has undertaken this procurement via a Most Suitable Provider Process under the Provider Selection Regime and this notice is an intention to award notice.

It is essential that the pathway supports the timely discharge of people at end of life, particularly for those people rapidly deteriorating for whom there is a limited window for a safe and appropriate discharge from hospital to be achieved.
