# **Description**

NHS Wales Shared Services Partnership (NWSSP) - Supply Chain, Logistics & Transport (SCL&T) is seeking to engage with the market in relation to a forthcoming procurement for the maintenance and statutory inspection of manual handling equipment located across multiple NHS Wales sites.

The intended contract will cover preventative maintenance, statutory LOLER and PUWER inspections, and associated remedial or emergency call-out work for NWSSP-owned manual handling equipment.

The anticipated contract will be established as a two-year call-off arrangement, with the option to extend for a further 12 months.
