The aim of this framework is to provide high quality products for the Nursery and Early Years market, including primary schools, nurseries, playgroups and childminders.

The purpose of this document is for suppliers to provide information regarding standard specifications which are available to the market, also YPO are trying to understand capabilities of the supply base. YPO have listed a number of requirements within each
