Northamptonshire Children's Trust wishes to invite Tenders for the Provision of Personal Care and Support Services for Children and Young People with Disabilities.

The Children's Trust is setting up a Framework Agreement for the provision of Personal Care and Support Services for children and young people with Disabilities for a period of 4 years.

The Contract has a maximum annual budget of £3,500,000 (exclusive of VAT) for the delivery of the requirement as set out in the Specification. This should be based upon the base 4-year contract, with the core service as detailed in the tender documentation.
