Description

Please note, before completing your tender response, a mandatory site visit to the Science Museum in London or the National Railway Museum in York is required. Any respondents who have not visited, will not be considered. Potential bidders should book the site visits by 5pm on Thursday 18th September.

To note: in March 2026 SMG will be completing the procurement of the Security officer provision. This process is considered to be in conflict with the above requirement and therefore should the successful provider from this framework wishes to bid for the security officer provision and were successful they would need to withdraw from the framework and a new tender would be completed.
