This is the fourth variation to the contract.

September 2025 - variation under PCR2015 Reg 72(1)(a) and 72(1)(b).

Contractor instructed to carry out further works within original scope at a cost of £2,869,956.12 ex VAT

Contractor instructed to carry out additional works not in original scope and less than 50% of contract value at a cost of £3,517,322.50 ex VAT - this is an extension to the additional works instructed on previous variation.

Need for additional works, services or supplies by the original contractor/concessionaire.

These modifications are required due to a combination of ensuring continuity of the required contractual works and allowing enabling works for asbestos related works uncovered during the course of the contract. UKHSA intends to issue before the end of 2025 a Preliminary Information Notice in respect of the forthcoming competitive tender for

asbestos removal and replacement works.
