### Description

Cornwall Council seeks private sector partners to deliver up to 350 residential units over three years through long-term private rental and Private Sector Leasing (PSL) models. The initiative aims to mobilise private investment to expand settled and temporary housing stock across Cornwall, supporting homelessness prevention and strategic housing objectives.

Estimated total value of rents/leases circa £7.5m
