As stated in the Notice for Mental Health Supported Living Phase 1, published on 15th October 2025 (reference:2025/S 000-065676) , Camden Council was unable to award the contract for Lot 3, the new Women's Mental Health Supported Living Service that went out to tender earlier this year.
