Description of the circumstances which rendered the modification necessary and explanation of the unforeseen nature of these circumstances:

This modification is required to implement the national supervised toothbrushing programme for 3-5-year-olds in early years settings, funded through the Family Hubs and Start for Life programme. The availability of this funding and the requirement to deliver the programme were not foreseen at the time of the original contract award. The modification does not render the contract materially different in character and remains within the scope of the original service specification.
