The ethos of the service is to provide high quality personalised reablement, to be outcome focused, and to enhance what the Individual can do themselves or with help from their support network.

No Conflicts of Interest were identified.

Relative importance of Key Criteria:

Social Value 5% - although Somerset Council's standard is to allocate 10% to Social Value, it was felt in this case that more should be allocated to the other Key Criteria and so this was reduced

Value Pass/ Fail - this was a pass/fail as Applicants were required to accept the proposed hourly rate in order to bid

Improving access, reducing health inequalities and facilitating choice 40% - this was seen as the most important Key Criteria for the service in question and therefore attracted the highest weighting

Quality and innovation 30% - having a good quality service with the ability to develop/

innovate was also seen as very important and given the second highest weighting

Integration, collaboration and service sustainability 25% - also a key area and therefore only a slightly reduced weighting from Quality and innovation
