 - The Provider's staff shall have the necessary knowledge, skills and experience of working with community organisations.
 - The Provider shall promote and demonstrate the benefits of physical activity to patients suffering from a range of physical and mental health conditions, i.e. obesity, high blood pressure, mild to moderate depression etc. and those who are not currently active.
 - The Service seeks to provide a range of exercise options in leisure centres for priority groups of low to medium risk clients, (including Phase 4 Cardiac Rehab), to develop the confidence, skills and motivation they need to become and remain physically active by:
