## Perpetrator Behaviour Change Programme Aims

This service is for community-based services for perpetrators of domestic abuse, to increase victim safety, protect and safeguard children, and reduce perpetrator recidivism.

Requirements of the service - Low - medium risk perpetrator behaviour change programme, training, support and supervision for professionals

1 year, 10 month Perpetrator Behaviour Change Programme = £181,810
