This contract has been awarded under the Health Care Services (Provider Selection Regime) Regulations 2023. For the avoidance of doubt, the provisions of the Public Contracts Regulations 2015 do not apply to this award.

Urgent circumstances provision was applied in line with the regulations due to changes made by the Local Authority to their contracted bed provision for P2 patients. It was necessary to urgently make arrangements for the provision of enhanced GP cover services to the newly commissioned care home beds.

The decision to commission the service was made by the ICB delivery team. Declarations of Interest were sought from all decision makers and no interests were declared.
