Description

Camden Council are procuring three Adult Pathway contracts. The services will provide accommodation and support for single homeless people in Camden. Two of the three contracts are for single men and the third is for a mixed gender service.

The service model for all three contracts will work to a Psychologically Informed Environment (PIE) and a Trauma informed model of support.

Tenderers who do not have suitable properties within the London Borough of Camden at the bidding stage should not submit a tender.
