Only the Company possesses the technical information to carry out the work required to achieve the ECPINS (Electronic Chart Precision Integrated Navigation System) software integration of any obsolescence solution within the WECDIS and WAIS equipment, as well as the maintenance of these systems, their technical support and the capability to provide training where required.

Accordingly, due to an absence of competition for technical reasons, the Contractor is considered as the only supplier that can provide the services and there are no reasonable alternatives to those services as required by the Authority.

The contract will not be awarded to an excluded or excludable supplier; a Contract Award Notice and Contract Details Notice will follow in accordance with Procurement Act 2023.
