Following requests from Bidders, and changes to the scope of Lot 1 products, Team Leidos has approved a 6-week extension to the tender return date i.e from 25/11/25 to 08/01/26. This extension also affects the deadline for answering further questions and the award date (estimated), which have been changed to 11/12/25, and 08/05/26, respectively. Contract start and end dates have also been amended to 27/05/26 and 26/05/30, accordingly.

Team Leidos are proud to be delivering the logistics commodities and services transformation (LCS(T)) Delivery partner contracts (LCS (T)/0001 dated 16.4.2015) on behalf of the UK Ministry of Defence (MoD) (the 'Prime Contract').
