This notice informs suppliers of an upcoming procurement under the Procurement Act 2023 using the Open Procedure. The Trust intends to engage with the market to gather feedback and insights prior to issuing the Tender Notice.

The Trust is intending to operate on a Trust-owned linen management system, where reporting and laundry services will be outsourced to a supplier. Suppliers should ensure they understand this operating model as part of their engagement and any subsequent tendering activity.
