The introduction of an alternative supplier would give rise to disproportionate technical difficulties in operation and maintenance, including, but not limited to, the risk of inconsistency in longitudinal data collection, misalignment of analytical processes, and disruption to established reporting mechanisms, as set out in paragraph 7(b).

Accordingly, the authority is satisfied that the proposed direct award to UCL is both necessary and proportionate, ensuring the seamless continuation of services and safeguarding the technical integrity of the Generation Study.
