Wigan Council are undertaking Preliminary Market Engagement to enable contractors to understand the requirements related to an urgent requirement to appoint a contractor to remove waste that has been illegally deposited at Bolton House Road, Bickershaw, Wigan WN2 4AB. This will require supplier to visit the site to understand the scope of the requirements. The quantity of waste Wigan Council expect to be removed is estimated to be in the region of around 4,000 tonnes. This was estimated following a LIDAR survey which calculated the volume of waste as 7978.21 metres cubed.
