Following publication of the Strategic Defence Review (SDR) and the Defence Industrial Strategy, the MOD is seeking to engage with Industry to discuss opportunities of the MOD Industry boundary in delivering Munition capability and increased resilience within the Supply Chain. To that end, MoD would like to invite Industry to an update on the Segmented Sourcing Strategy (SSS) and one-to-one engagements on the 8 Jan 26 at the Battlelab.
