Description

The Foreign, Commonwealth & Development Office (FCDO) is seeking to acquire financial consultancy services to support the UK government's flagship Mobilising Institutional Capital through Listed Products (MOBILIST) programme. This initiative aims to develop investment solutions that contribute to achieving the Global Goals for Sustainable Development and advancing climate transition. The contract will have a duration of 24 months, with an additional 12 month extension option based on supplier performance and need. The total contract value is £750,000 (ExVat) which includes a £500,000 (ExVAT) financial limit and £250,000 financial uplift option. The selected supplier will be expected to deliver market intelligence, investment expertise (such as exit readiness analysis, valuation services, and investment pack reviews), and ongoing portfolio monitoring (including broker research, regulatory updates, and performance reporting).
