The Council is changing the way that waste and recycling is collected across Stockton. At present, general waste is collected weekly and recycling is collected fortnightly. From April 2026, general waste will be collected fortnightly, and recycling will be collected weekly.

At present, the Council collects around 8,500 tonnes of DMR per annum. The Council has worked with WRAP on modelling the upcoming changes and it is anticipated that the Council will collect an estimated 18,000 tonnes of recycling including food waste - further material breakdown is available within the tender documents.
