## Description

This evidence review will be to support safe staffing in Children and Young People's Critical Care Services in NHS hospitals. The scope includes both intensive and high dependency care delivered within discrete locations such as Intensive Care Units (ICU), High Dependency Units (HDU) or combined/co-located units. The guidance will focus on critical care service provision at Level 3, though Level 2 will be considered as appropriate.

Services are delivered in people's homes, including care homes, but also in community hospitals, intermediate care facilities and clinics.
