Description

The Advanced Manufacturing Innovation Centre (AMIC), led by Queen's University Belfast, is key to an exciting future for manufacturing in Northern Ireland, as an industry-led, open-access manufacturing and engineering innovation centre with state-of-the-art facilities and an expert engineering team, underpinned by academic excellence.

AMIC is expanding its core capabilities in Digital Factory, Smart Design, Sustainable Polymers and Composites Nanotechnology and Photonics. With a growing team of

engineers and technologists (currently 50 strong) and building upon a track-record of collaboration with manufacturers it will deliver industry 4.0 solutions for industry. Supported through a £98M investment via Belfast Region City Deal, a 10,000m² Factory of the Future facility will open at Global Point Newtownabbey in early 2026. The equipment being purchased is critical to the organisational strategy.

As part of this project Queen's University Belfast wish to procure a Femtosecond Laser Workstation.

As part of this project, Queen's University Belfast is seeking expressions of interest from suppliers as we wish to procure a Femtosecond Laser Workstation.

Queen's staff wish to engage with suppliers prior to procuring this equipment to:

- 1 - gain a better understanding of what the market can offer and if the market can respond to a tender meeting our requirements.
- 2 - identify potential suppliers able to provide the requirement.
- 3 - understand potential lead times.
- 4 - gain an understanding of the commercial profile for the requirement.
