Description

This provision will be specifically designed for women who are experiencing, or have a history of, Violence Against Women and Girls (VAWG) and multiple disadvantage. The accommodation must be staffed 24 hours a day, 365 days a year, and equipped to support women with complex and high-risk needs.

The Authority requires 40 units of accommodation-based support under this Lot. While the Authority's contract will cover support services only, bidders must demonstrate their ability to provide suitable accommodation—either directly, through a consortium, or via sub-contracting arrangements. Accommodation costs will be met through rent and Housing Benefit. The Authority will not be party to any licence or lease agreements between the Provider and the accommodation landlord, and such arrangements will fall outside the scope of the contract. To be eligible, tender submissions requires 40 units with a minimum of 10 units of accommodation-based support located within a single site
