Scope

Description

The Council is seeking a supplier(s) to deliver Enhanced Early Years Provision (EEYP) for children aged 2-4 years whose identified complex needs make it difficult to attend provision that is ordinarily available.

The intention is to deliver additional EEYP within Wyre Forest, Bromsgrove, Redditch, Evesham/Pershore, and Malvern.

WCC are looking to commission the following number of places in each locality:

- Redditch/Bromsgrove by either
 - i. Redditch - 6 places a year; and
 - ii. Bromsgrove - 6 places a year; or
 - iii. Redditch/Bromsgrove - 12 places a year;
- Wyre Forest: Up to 12 places a year;
- Pershore/Evesham: Up to 12 places a year; and

- Malvern: Up to 6 places a year
