Scope of Requirement

AMRC Castings has many gas fuelled processes which we are looking to decarbonise, in particular a 656kW kiln used for firing the ceramic shells used for investment casting. The thermodynamic requirements of the process and on-site electrical grid constraints mean that electrification is not a viable option, and as such, we are interested in ways of decarbonising the natural gas supply to the kiln.

We are aware that fuel switching to low carbon hydrogen is technically possible, but currently low carbon hydrogen is significantly more expensive than natural gas which would result in uneconomically high operational costs.

We are interested in installing a natural gas decarbonisation system to supply our investment mould flash fire kiln, but we need the solution to be comparable economically to natural gas.
