Ty Parc is a 24 hour homelessness hostel that provides emergency accommodation to single people, couples and families, who are homeless/potentially homeless and has/have been accepted has being owed a duty by Blaenau Gwent County Borough Council's Housing Solutions Team under the Housing (Wales) Act 2014. Support is provided to individual's aged 16 years and older (there is no upper age limit).
