This notice relates to the process set out in Regulation 10(9) of The Health Care Services (Provider Selection Regime) Regulations 2023.

Direct award - Process C

There is an existing provider for the healthcare services, and their contract is ending. The proposed contracting arrangements are not changing considerably.
