The purpose of this preliminary market engagement notice is to notify the market that Driver and Vehicle Standards Agency (DVSA) will seek to find a single supplier for the provision of services relating to the collection and selling of redundant DVSA testing equipment.

DVSA will continue to reduce the volume of its Government Vehicle Testing Station (GVTS) Estates in accordance with observed incremental growth rate in the Authorised Testing Facilities (ATF's) market and moving the Individual Vehicle Approval (IVA) scheme out to privately owned sites called Vehicle Examination Facilities (VEF's). This move was set up to bring the work that DVSA conduct closer to Vehicle Operators and Vehicle Maintainers; by encouraging private individuals and entrepreneurs to set up an

ATF's and/or VEFs for private and public use. This was a strategic and positive shift in the way DVSA conducts its vehicle testing business.
