The Trust anticipates that researching the market and completing a competitive procurement will require a minimum of 6 months, and this supports the clinical urgency to maintain service continuity and avoid harm to patients. Without this contract, patients' diagnosis and treatment would be delayed, resulting in prolonged pain and potential deterioration of their clinical conditions.

Surgical procedures would carry higher risk without these scans and reports, which provide essential anatomical information used in treatment planning and help reduce operating time and the likelihood of complications.
