The aim of the service is to provide tailored and evidence-based specialist therapeutic support and treatment to survivors of sexual abuse and violence in Norfolk and Waveney.

Improving access, reducing health inequalities, and facilitating choice 12%

Social value 10%

Lot 2

Quality and Innovation 50.0%

Value (tariff based) 10.00%

Integration, collaboration, and service sustainability 20.0%

Improving access, reducing health inequalities, and facilitating choice 10.0%

Social value 10.0%

The rationale for this was based on the detailed list of all requirements according to the specification and requirements of the integrated care system with the winning bidder awarded the highest combined weighted score across the 5 key criteria.
