His Majesty's Courts and Tribunals Service (HMCTS) is undertaking discovery to:

- understand what solutions, services and innovations are available to support participation in hearings via video; and
- explore how existing or emerging market solutions might address remote participation challenges.

HMCTS invites interested suppliers to attend a webinar on 21 January 2026.

HMCTS will set out user needs, potential future capabilities, and challenges the programme is looking to address. Programme objectives, problem statements and real-world examples that illustrate the challenges users and staff face today will all be presented.

This preliminary market engagement will inform HMCTS' future procurement strategy.
