



# **AGREEMENT**

**Cheshire Fire Authority**

**THIS AGREEMENT** is made on the 11/12/2025

**BETWEEN**

1. Cheshire Fire Authority, HQ, Sadler Road, Winsford, Cheshire, CW7 2FQ, United Kingdom (the "Authority");

**AND**

2. Sliced Bread Animation Limited, The Foundry, 5 Forest Road, London, E17 6ZJ, United Kingdom (Company Number 04564021).

**WHEREAS:**

It is the intention of the Authority to provide a New Immersive Learning Water Feature at Safety Central which will include an element of servicing and maintenance (the Goods/Services). To this end, the Authority issued a regulated below threshold tender via the contracting authority's e-tendering portal Sell2Bluelight on 25<sup>th</sup> September 2025 inviting bids for the Goods/Services. The Contract has been awarded to Sliced Bread Animation Limited. The contract term will be for a period of three [3] years (the initial term). There is an option to extend the Contract for a further two [2] years in periods of not less than twelve [12] months. This will be subject to;

- All parties agreeing:
  - The price being acceptable
  - The satisfactory performance of the Contractor as agreed by Cheshire Fire Authority
  - The Service still being required.

- The Contract is subject to this Agreement.

**IT IS NOW AGREED** as follows:

1. THE following documents are incorporated herein and are signed by the parties in pursuance of that;
  - 2537F Specification;
  - 2537F ITT Instructions for Bidders;
  - 2537F ITT Statement of Requirement;
  - 2537F ITT Response to Tender – Complete;
  - 2537F Copy of Pricing Schedule FINAL – Complete;
  - 2537F Presentation that formed part of the Evaluation;
  - Information Guidelines for Contractors 0125; and

- 2537F CFA Terms and Conditions of Contract.

This Agreement shall not be varied or amended unless such variation or amendment is agreed in writing by or on behalf of the Authority and by a duly authorised representative of the Contractor.

2. The Agreement between the parties runs from the commencement date of 3<sup>rd</sup> December 2025 until the expiry date of 2<sup>nd</sup> December 2028 inclusive (the initial term). There is an option to extend the Contract for a further two [2] years in periods of not less than twelve [12] months to end at the latest on 2<sup>nd</sup> December 2030.
3. IN consideration of the Authority's obligations herein the Contractor will provide the Service in accordance with this Agreement and the documents contained herein at the Contractor's Pricing for the Services as specified in the Contractor's Pricing Schedule.
4. IN consideration of the Contractor's obligations herein, the Authority will pay the Contractor the sums as per the Contractor's Pricing Schedule. Payments will be made in accordance with the Terms and Conditions of Contract.
