Scope of Work

Background

Following a recent compliance system failure by a secondary site inspection was conducted to assess the current fall protection systems. The existing "ridge systems" do not comply with the current BS7883:2019 standards. It is therefore recommended that the systems be replaced and upgraded to meet current safety regulations.

SWP Requirements

- Installation of compliant fall protection systems in accordance with BS7883:2019
- Use of Kee Line and Kee Walk systems and/or equivalent system in accordance with BS7883:2019- Safe access between roof levels accordance with BS7883:2019

Proposed Solution

JSIU Lower Roof

- Kee Walk System (and/or equivalent system in accordance with BS7883:2019):
Supply and installation of a levelled Kee Walk walkway around the perimeter of the roof (excluding one section on the right-hand side).
Approximate length: 72 metres
- Kee Line System (and/or equivalent system in accordance with BS7883:2019):
Supply and installation of Kee Line fall protection system on the inside of the Kee Walk panels.
Approximate length: 80 metres
21 anchor posts to be installed
Positioned a minimum of 2.5 metres from the roof edge
Designed for use with 2-metre fixed length lanyards
Certified for restraint use

JSIU Mid-Level Roof

- Kee Walk System (and/or equivalent system in accordance with BS7883:2019):
Supply and installation of a levelled Kee Walk walkway down the ridge of the roof.
Approximate length: 21 metres



- Kee Line System (and/or equivalent system in accordance with BS7883:2019):
Supply and installation of Kee Line system around the perimeter, installed on the inside of the Kee Walk panels.
17 anchor posts to be installed
Positioned a minimum of 2.5 metres from the roof edge
Designed for use with 2-metre fixed length lanyards
Certified for restraint use
- Kee Step Units (and/or equivalent system in accordance with BS7883:2019):
Supply and installation of 2 Kee Step units to provide safe access to the link roof between the HQ Main Block building and the HQ JSIU mid-level roof.
Current access involves a 1400mm drop to the link roof and a 1400mm rise to the HQ building

Installation Notes

- All components will be fixed using standing seam clamps on the roof sheets.
- All systems will be designed and installed in accordance with BS7883:2019.
- Method Statements and Risk Assessments are required before the Commencement of any work
- A crane will be required to transport materials to the roof due to limited access around the building.
- Required certification to be provided following the completion of works
