Bidder	a person (e.g. company, limited liability partnership, firm, joint venture, etc) bidding in this Procurement Process		
Procurement Process	the entire tender process from start to finish including the Selection Stage, ITT Contractual Compliance and ITT Quality & Commercial stages		
Proposed Contract	the contract that YWS and the successful Bidder(s) will enter on completion in full of the Procurement Process		
Selection Stage	the invitation to qualify stage of the Procurement Process during which YWS will identify Bidder(s) which meet YWS's minimum requirements		
Selection Stage Criteria	the criteria by which the Selection Stage Questionnaire will be assessed and scored		
ITT Contractual Compliance	the invitation to tender contractual compliance stage of the Procurement Process during which Bidder(s) will agree the terms and conditions of the Proposed Contract		
Selection Stage Questionnaire	the questions asked at Selection Stage		
ITT Quality & Commercial	the invitation to tender quality & commercial stage of the Procurement Process during which Bidder(s) are assessed using criteria to assess the quality and commercial aspects of their bid for the Proposed Contract

1. Selection Stage

1.1 Overview

The purpose of the Selection Stage is to identify Bidder(s) capable of meeting YWS's minimum requirements.

YWS will evaluate the completed Selection Stage Questionnaire against predefined criteria to assess if the Bidder(s) are able to meet YWS's minimum standards to undertake the Proposed Contract.

YWS's rules for procurement processes (version 2) apply to this Procurement Process.

1.2 Selection Stage Questionnaire

The Selection Stage Questionnaire is a formal submission. All Bidder(s) must complete and submit the Selection Stage Questionnaire in full, failure to do so may invalidate the Bidder(s) submission.

No alterations or additions to the Selection Stage Questionnaire shall be permitted, unless authorised by YWS via the clarification process.
