

Service and Software Subscription Order Form

Agreement

This Agreement is between Purple Matrix Limited, Unit 3 The Yard, 122 East Road, London N1 6FB (“Purple Matrix” or “we” or “us”) and The Princess Alexandra Hospital NHS Trust (“you”) on 21/04/2025.

This Order Form and the Master Services and Software Subscription Agreement, attached set out what we have each agreed will be the terms of the agreement between us (the “Agreement”).

In the event of any conflict between the provisions of any of the documents comprising this Agreement the following order of precedence will apply:

- 1. The Service and Software Subscription Order Form shall override the following;
- 2. The Master Services and Software Subscription Agreement

Capitalised terms not defined herein shall have the meaning as defined in the Master Services and Software Subscription Agreement save where the context requires otherwise.

When signed by each of us, this Agreement will form a valid contract and will be the entire agreement between us. It will replace the provisions of all previous proposals or discussions between us relating to the subject matter of this Agreement.

We may change the terms of the Master Services and Software Subscription Agreement from time to time provided that: (i) we notify you in writing of any such changes as soon as is practicable but no later than 30 days before they are proposed to take effect; and (ii) your continued use of the Services shall confirm your consent to any such changes. In addition, We shall inform you if any changes adversely affect your use of the Services and provide you with such information relating thereto as you may reasonably request. If we do not do so then you may withhold your consent and the terms of the Master Services and Software Subscription Agreement shall continue to apply without modification.
