**AGREEMENT FOR MANAGER

THIS AGREEMENT is made the

BETWEEN

1. The Police and Crime Commissioner for Cheshire of Constabulary Headquarters, Clemonds Hey, Oakmere Road, Winsford, Cheshire, CW7 2UA, England (the PCC)

AND

2. Alemba Limited, 24 Minto Street, Edinburgh, EH9 1SB (the Contractor)

WHEREAS:

- 1.1. For the purchase of 126 ASM Concurrent licenses (hereinafter “the Service”) to the Police and Crime Commissioner for Cheshire (the “PCC”) and the Chief Constable of Cheshire (CC). The PCC is the contracting authority for the provision of this service.
- (1) It is the intention of the PCC to support Cheshire Constabulary in respect of the establishment of a contract for the purchase of 126 ASM Concurrent licenses (the Service).
- (2) The Contractor has provided Quotation Number Q91347-1 dated 3rd June 2025 for the provision of the goods/services and pricing, and the Quotation has been accepted subject to this Agreement.

IT IS NOW AGREED as follows:

1. THE following documents are incorporated herein:
 - the Terms and Conditions CPA/SPU/2580P
 - Quotation Number Q91347-1
2. THE Agreement between the parties will be for a 4-year period, 4th July 2025 until 3rd July 2029. There will be an option to extend the agreement by three (3) periods of one (1) year.
3. IN consideration of the PCC’s obligations herein the Contractor will provide the Goods and Service as per Quotation Number Q91347-1
4. IN consideration of the Contractor’s obligations herein, the PCC will pay the Contractor the sums due as detailed in Quotation Number Q91347-1 under the PCC’s normal payment terms, plus any payable VAT.
5. IN the event of any conflict the Price together with any clarification of the requirements shall prevail and this Agreement shall not be varied or amended unless such variation or amendment is agreed in writing by or on behalf of the PCC and by a duly authorised representative of the Contractor.
