1. **THE CITY OF LIVERPOOL COLLEGE** a College of further education whose principal place of business is Learning Exchange, Roscoe Street, Liverpool, L1 9DW (the "**College**", "**We**", or "**Us**"), and <> 2. **Orangebox Training Solutions UK LTD** a company registered in England and Wales under number 07047501 whose registered office is Exchange Building, 66 Church Street, Hartlepool, England, TS24 7DN ("Partner Provider" or "Subcontractor").

PART 1: Introduction, Guidance and Requirements

Introduction Introduction and Recital of Intention

- (A) The Main Provider is body concerned with the provision of education and training to learners.
- (B) The Subcontractor is in a position to assist the Main Provider in providing education and training to learners.
- (C) The Main Provider wishes to provide education and training to certain Learners by making use of the services of the Subcontractor.
- (D) The Main Provider is subcontracting to the Subcontractor in order to:
 - i. provide a niche service, emerging market or works with a specific learner target group. We work closely with partner links to access new sectors.
 - ii. support the College where we have capacity issues. We are able to widen our curriculum offer; offering new areas of curriculum which the College does not offer.
 - iii. supports our strategic agenda e.g. meeting the needs of Liverpool City Region skills priorities and demands from employer and communities.
 - iv. Partners have the ability to engage with specific target groups, working with learners with disabilities, disadvantaged postcodes and students with multiple disadvantages.
- (E) This Agreement should be read in conjunction with the Main Provider's subcontracting policy which is available on the https://www.liv-coll.ac.uk/the-college/subcontracting/page of the Main Provider's website.
- (F) The Main Provider and the Subcontractor have agreed that the provision of services by the Subcontractor shall be subject to the terms set out in this Agreement in order to provide a framework for an effective working relationship between the parties, to clarify their respective roles and responsibilities, to set out the applicable principles and to ensure the required objectives are met.

Amendment to Schedule 1 Part 1 of the Original Learning Provision Subcontract OBOXASF 25/26 all contract stipulations apply.

- 1. Non- Devolved Maximum Contract Value ("MCV") = £16,347 (Term1). Out of Area (Non- Devolved) this is subject to affordability and partner performance.
- 2. Non-Devolved delivery to be in the Northwest area, within approximately an hour's travelling distance from Liverpool and/or no further than 50 miles travelling from Liverpool.

MCV 23/24 Contract Value – £16,347 (Term 1)

The MCV will be increased to £32,694 (increase of £16,347 for Term 2 and Term 3) subject to performance review at the end of Term 1. See table below
