1. Project Overview

1.1 Introduction

Callington Town Council is seeking to upgrade the current skate park equipment in the Saltash Road Recreation Ground, Callington, Cornwall.

The existing equipment, installed in late 2016, is now approaching the end of its life. Following community engagement and consultation with skaters, BMX riders, and scooter riders, plans are underway to develop a new replacement concrete skate park.

Following community engagement and consultation, a new concrete skatepark with features to suit all ability levels is being sought.

The successful contractor will be expected to work in close partnership with the Calli Skate Park committee, and council staff throughout the project.

1.2 Location/site

The site is owned by Callington Town Council under title number CL298979 and is accessible to the public, should they so wish, through the day and night.

The area is adjacent to a free car parking area. Access is from an adjacent car park, double gated area or numerous gated entrances. The current facility is circa 15m from the boundary of the nearest football pitch; it is also circa 15m from the nearest play area (including a bund). These are adequate distances to safely separate the different activities going on in the site. The toddler play area is fenced.

The submitted design must fit within the footprint specified in the drawings. The area shown is the maximum footprint.

To be successful the bidder will be required to adhere to the design brief and designs provided by the Calli Skate Park committee to cater for Skateboarding, BMX, scooters and roller skating.

The proposal should not impact on any ditch or drainage feature of the wider site. The Tenderer must ensure that all required investigations are made prior to submission of the Tender and that the tender submitted is done so with full consideration of all the work required to ensure that land is suitable for development with appropriate costings reflecting these aspects.



1.3 Design

Contractors are invited to review the requirements outlined in this project brief and submit a fully costed tender including specification for the construction of a concrete facility on the existing site, replicating the attached plan within this tender document. Proposals should also detail any funding options the contractor can provide or facilitate. Demonstrated prior experience in similar projects could be an advantage. Improvements to the design will be considered and should be itemised as an extra / saving.

- Safety signage, material failure and build insurance (PI, PL & EL insurance) to be included in quotations.

Any ground water around and/or within the site must be intercepted and properly dealt with. Surface water must not pool or remain on the skatepark surface. If necessary, drainage to be incorporated.

All aspects of the design must conform to the British safety standards, as outlined in the British Standards Institution specification EN 14974 and satisfy the recommendations of RoSPA's "Prevention of Skateboarding Accidents and Litigation Management.

Tenders received will be considered by the Calli Skatepark Committee, Council members and staff.

CDM Duty Holders:

This project will be undertaken in accordance with the Construction (Design and Management) Regulations 2015 (CDM 2015). Duty holders are identified as follows:

- Client (the Skate Park Committee): Responsible for making suitable arrangements for managing the project, ensuring sufficient time and resources and confirming that duty holders are appointed.
- Principal Designer / Principal Contractor (the Skatepark Builder): The appointed skatepark builder will act as both Principal Designer and Principal Contractor. They will be responsible for planning, managing, monitoring and coordinating health and safety during both the design and construction phases, including eliminating or controlling foreseeable risks.
- Other Designers / Contractors (as applicable): Any additional designers or subcontractors must comply with their CDM duties and cooperate fully with the skatepark builder and the Client.

All parties must work together to ensure compliance with CDM 2015 and the safe and successful delivery of the skatepark project.



Construction Plan

1. Scope of Works. The works will include:

- Site preparation and demolition of existing fence.
- Demolition and disposal of waste through the proper routes
- Earthworks, grading and sub-base preparation.
- Installation of drainage systems.
- Construction of reinforced concrete skatepark elements (bowls, ramps, platforms, coping).
- Installation of street-style features (rails, ledges, stairs).
- Perimeter works including pathways and landscaping.
- Site clean-up, quality checks, and handover.

2. Methodology

2.1 Mobilisation

- Establish site compound, temporary fencing and signage.
- Set out works in accordance with approved design drawings.

- Conduct pre-start meetings with subcontractors and suppliers.

2.2 Site Preparation

- Clear vegetation, debris and unsuitable materials.
- Carry out excavation to design levels.
- Import and compact subgrade fill where required.

2.3 Drainage & Utilities

- Install sub-surface drainage to prevent water pooling.
- Connect to existing stormwater infrastructure.
- Install conduits for future lighting and services.

2.4 Concrete Works

- Coping and edging hot dipped galvanised. Cut ends to be treated with corrosion resistant paint system
- Formwork, steel reinforcement and shotcrete application for bowls and ramps.
- Machine finishing followed by hand-trowelling for smooth riding surfaces.
- Expansion joints, coping stones and steel edges installed.

2.5 Ancillary Works

- Install prefabricated hot dipped galvanised rails, ledges and modular features.
- Construct pathways, seating areas and viewing zones.
- Landscape the surrounding area.

3. Health, Safety & Environmental Management

- Works to be carried out in accordance with [local construction safety legislation].
- Dust suppression and noise control measures.
- Daily toolbox talks and risk assessments.
- Waste management and recycling plan.
- Public safety maintained through secure site fencing and restricted access.
- Working hours 0800 to 1700.
- All operatives working on site should have relevant CSCS cards.

1.4 Budget

All pricing should be in GBP (£). Pricing should be valid for a minimum of 12 months from the date of the tender deadline. Prices will be fixed for the duration of the contract.

Following completion, any disturbance or damage to surrounding grass and pathways are to be reinstated using topsoil and good quality cultivated turf. All levels of surrounding land must be flush with levels of edging kerbs and/or surface. All hard surfaces must be washed clean and ready for use, these costs to be included in the price.

Tender prices must include an independent post installation inspection by an RPII certified inspector and the report to be issued to the Council as part of the completion process, any remedial tasks identified by Calli Skate Park committee or RPII Inspector during the build are the responsibility of the contractor and must be carried out and signed off before final payment is made by the Calli Skate Park committee.

All elements of the submitted design are subject to planning approval and approval by Callington Town Council.

Interim payments may be paid following agreement between the Council/Calli Skate Park committee and the contractor. Tender submission should state payment terms.

Construction by Principle Contractor to be completed in one visit.

All labour to be included.

The Principle Contractor to provide all plant / lifting apparatus necessary for construction, offloading and distribution of all equipment around the site.

Principle contractor to supply the following: any civil/building works, welfare facilities, site security, skips for disposal of packaging materials, supply of power and cabling for site tools.

In the event that the Contractor fails to complete the Works by the agreed Completion Date (as may be extended in accordance with the Contract), the Contractor shall be liable to pay the Employer liquidated damages at the rate of 1% of the Contract Price per week (or part thereof) of delay, up to a maximum aggregate of 10% of the Contract Price.

The Contractor shall be fully conversant with the project by reading the documentation and visiting the site. Any issues or queries shall be raised by the Contractor prior to submission of their tender. Tenders should be submitted in email/electronic format but will require a hard copy sent by post or hand delivered.

All formal communication that the Contractor wishes to be taken into account during the evaluation should be directed to the Clerk of the Council, Jo Taylor – clerk@callington-tc.gov.uk . Questions will be directed to a named person such as the Chair of the Calli Skate Park Committee or the Clerk of the Council.

Council representatives and/or committee members of Calli Skatepark will be available to hold site

visits, contact should be made with the Clerk to arrange a mutually convenient time to do so. There is access to the site at all times should a contractor wish to visit on their own.

You should inform the Clerk of your intention to bid to be able to receive any updates to the Tender process or other relevant communication.

2.2 Submission of Tender

Tenders will be accepted by email with the subject heading “Confidential: Skate Park Tender” sent to the Clerk of the Town Council, Jo Taylor – clerk@callington-tc.gov.uk but a hard copy must also be received by post or delivered by hand in an envelope labelled “Confidential Skate Park Tender” addressed to The Clerk, Callington Town Council, The Town Hall, New Road, Callington, Cornwall, PL17 7BD.

Applications must be received by **1700 on 14th November 2025**

No applications will be considered if they are received later than the date and time specified unless at the Council’s discretion, a deadline is given and the reasons for this extension are published along with the new date/time.

Costs should be itemised for each element to allow for comparison between suppliers.

If Callington Town Council and/or the Calli Skate Park committee has a query and suspects an error has been made in the final quote they reserve the right to seek clarification as necessary from the contractor only.

Contractors are required to keep the prices fixed and tenders valid for 12 months from the deadline of the tender.

The Council/ Skate Park Committee may reject tenders they feel do not comply with the tender document.

The Council /Skate Park Committee is not bound to accept the lowest tender, nor does it guarantee that a tender will be awarded.

The Council/Skate Park Committee Chair will contact all contractors after the Full Council has resolved which tender to accept.

All information supplied by the Council in connection with this invitation to tender shall be regarded as confidential by the Contractor except such information that may be disclosed for the purpose of obtaining sureties and quotations necessary for the preparation of the tender. The tender documents shall remain the property of the Council.

All information submitted to the Council may need to be disclosed and/or published by the Council in compliance with the Freedom of Information Act 2002.

If you consider any aspect of your tender is commercially confidential you should explain why the Council will retain the right to disclose this information.

You will be required to submit the following information:

The Council reserves the right to automatically reject a bid that has not supplied the documents requested or given adequate reasons as to why the information cannot be provided.

3. Evaluation

All submissions will be assessed to ensure that they comply with the Town Council's Financial Regulations and Standing Orders.

The Contractor should indicate whether they have visited the site and that they have installed similar projects

The Calli Skate Park Committee and Town Clerk will delegate some or all of its members to assess and select applications.

Contractors shall clearly identify the construction material for each element and provide a guarantee of the life expectancy of the facility, which should accompany the designs.

A supplier questionnaire will need to be submitted and if a contractor does not meet some or all of the essential criteria they will be rejected.

3.1 Evaluation Weighting

Initial evaluation will be based accuracy on the Skate Park project committees brief, design and budget.

Full evaluation will then be based upon the following criteria and weighting:

3.3 Award Questions

Approach
The Applicant shall provide a method statement detailing how it would plan, manage and deliver the project.
The Council is looking for: - evidence of the applicant's previous experience in relation to managing and delivering projects of a similar nature - evidence of the applicant's previous experience of collaborating with key stakeholders and engaging in consultation with young people - relevant project examples which demonstrate the applicants' track history of successful delivery.
Quality
The Applicant should provide a Risk Assessment and method statement detailing how it proposes to deliver a high quality skatepark that delivers the young people's aspirations on time, within budget, within any relevant planning constraints at competitive construction rates.
The Council is looking for: - evidence that the Applicant understands the importance of managing key stakeholder's expectations within a set budget - a warranty against any structure of a minimum of 15 years - relevant other councils who could provide copies of safety checks/ROSPA reports would be useful.
Previous Experience
The Applicant should provide examples of previous work and similar projects and testimonials
The Council is looking for: - examples of similar projects which demonstrate the applicant's track history of successful delivery - explanations of any problem solving that has been undertaken in other projects.
Management and Communication
The Applicant should provide details of the team involved in the delivery of the contract and an outline programme with key contacts.
The Council is looking for - the appropriateness of the project team to meet the requirements of the project - details of their previous experience - how the project will be managed and - how the project team will communicate with the Council and key stakeholders throughout the project.

Programme
The applicant should provide a timetable for each stage of construction with expected timescales and contingency measures.

The applicant should provide costs.

3. “You” / “Your” refers to the potential Tenderer completing this standard Business Questionnaire i.e. the legal entity responsible for the information provided. The term “potential Tenderer” is intended to cover any economic operator as defined by the Public Contracts Regulations 2015 (referred to as the “regulations”) and could be a registered company; the lead contact for a group of economic operators; charitable organisation; Voluntary Community and Social Enterprise (VCSE); Special Purpose Vehicle; or other form of entity.
4. Please ensure that all questions are completed in full, and in the format requested. If the question does not apply to you, please state ‘N/A’. Should you need to provide additional information in response to the questions, please submit a clearly identified annex.
5.
