

AGREEMENT

Cheshire Fire Authority

And

Piranha Audio Visual Limited

Maintenance Service for Audio-Visual Equipment

CPA/SPU/2659F

BETWEEN

1. Cheshire Fire Authority, HQ, Sadler Road, Winsford, Cheshire, CW7 2FQ, United Kingdom (the "Authority");

AND

2. Piranha Audio Visual Limited, Unit 12 Quakers Coppice, Crewe Gates Industrial Estate, Crewe, United Kingdom (Company Number 0811612).

WHEREAS:

It is the intention of the Authority to provide a Maintenance Service for Audio-Visual Equipment at Lymm Safety Central (the Service). This includes any new or additional requirements that may arise. To this end, the Authority issued a Request for Quote (RFQ) via the contracting authority's e-tendering portal Sell2Bluelight on 21st July 2025 inviting bids for this service. The Contract has been awarded to Piranha Audio Visual Limited. The contract term will be for a period of three [3] years (the initial term). There is an option to extend the Contract for a further two [2] years in periods of not less than twelve [12] months. This will be subject to;

- All parties agreeing:
- · The price being acceptable
- The satisfactory performance of the Contractor as agreed by Cheshire Fire Authority
- The Service still being required.
- The Contract is subject to this Agreement.

IT IS NOW AGREED as follows:

- THE following documents are incorporated herein and are signed by the parties in pursuance of that;
 - 2659F Specification for the Maintenance of Audio Visual Equipment;
 - 2659F RFQ for the Maintenance of Audio Visual Equipment;
 - The Contractor's response dated on 17th August 2025 entitled 'Piranha 2659F RFQ for the Maintenance of Audio Visual Equipment' and any subsequent clarification questions/responses;

- The Contractor's Pricing Schedule received with the Contractor's response entitled 'Piranha_Maintenance Contract Pricing Schedule_Audio Visual' and any subsequent versions as agreed between the Authority and the Contractor;
- Contractors Working on Fire Authority Property;
- Ethical Procurement Strategy; and
- 2659F Terms and Conditions of Contract.

This Agreement shall not be varied or amended unless such variation or amendment is agreed in writing by or on behalf of the Authority and by a duly authorised representative of the Contractor.

- 2. The Agreement between the parties runs from the commencement date of 1st October 2025 until the expiry date of 30th September 2028 inclusive (the initial term). There is an option to extend the Contract for a further two [2] years in periods of not less than twelve [12] months to end at the latest on 30th September 2030.
- 3. IN consideration of the Authority's obligations herein the Contractor will provide the Service in accordance with this Agreement and the documents contained herein at the Contractor's Pricing for the Services as specified in the Contractor's Pricing Schedule.
- 4. IN consideration of the Contractor's obligations herein, the Authority will pay the Contractor the sums as per the Contractor's Pricing Schedule. Payments will be made in accordance with the Terms and Conditions of Contract.
