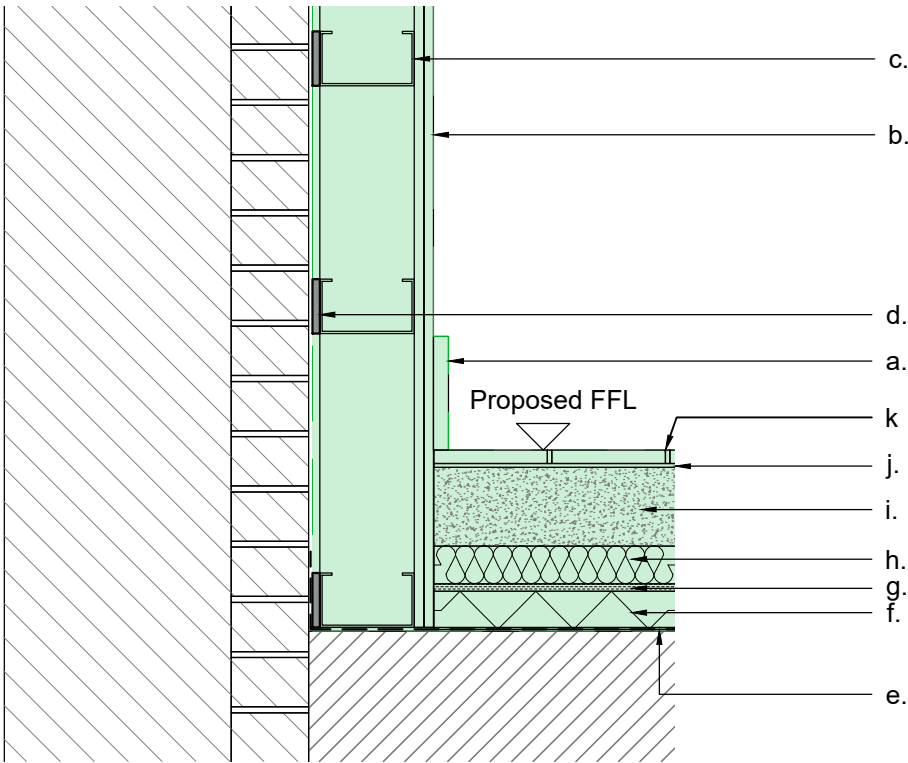

Key

Junction between ramp and historic fabric detail

- Fabric to be carefully removed or altered
- New fabric by others - refer to Jamie Fobert Architects' design information

- Modern fittings carefully removed. Finishes and drained cavity waterproofing membrane carefully stripped back to reveal bare brickwork.
- Previous fixings to be made good, generally in mortar to match existing. Subject to mortar analysis during strip-out.
- Existing floor covering to be carefully removed back to subfloor
- Existing suspended floor, if in evidence, to be carefully removed.
- Floor surface to be taken back to subfloor, pending further historic analysis and investigation following stripout.

New lining by Jamie Fobert Architects to perform to required fire acoustic and thermal performance to comprise:

- Painted softwood skirting board
- One or two layers of acoustic or otherwise plasterboard lining
- Metal studwork sized according to performance requirements
- Plastic shims between brickwork and new studwork

New ramped floor by Jamie Fobert Architects to perform to required fire acoustic and thermal performance to comprise:

- Damp proof membrane
- XPS Insulation
- CDM Floor Membrane
- Rigid insulation
- Floating screed
- Adhesive layer
- Tiles

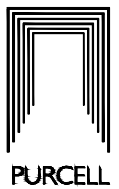
