With references to the aforementioned contract on behalf of UK Industrial Fusion Solutions Ltd. (the "Client"), I am pleased to confirm an uplift in the contract value to encapsulate further scope of work, as permitted by Section 74 Schedule 8 of the Procurement Act 2023, on grounds of *Additional goods, services or works*.

Contract variation:

This contract variation extends the scope of the existing PIMS contract to incorporate elements of Engineering Governance, specifically focusing on embedding governance into PIMS capabilities and aligning them with the Engineering Management Framework (EMF).

The uplift will deliver the following:

1. Foundational Work:

Review and define core PIMS building blocks:

- Approval Routes to ensure objects are raised, reviewed and handled in the most effective way possible.
- Work to define templates to ensure that steps are repeatable and efficient.
- User Groups that relate to appropriate approval chains.
- Work with Process Owners to co-develop and align these elements with governance mechanisms such as Technical Delegation of Authority.
- Ensure consistency across PIMS modules to support a unified governance approach.
- Use this foundation to assess and improve existing PIMS capabilities.

2. New Capability Setup:

- The Assystem team will work with UKIFS Capability and/or Process Owners and other key stakeholders to develop a set of Engineering Processes that are integrated with PIMS, align with EMF policy and governance requirements.
- The Process Owner (typically a UKIFS person with Assystem support) will work with Dassault PIMS team to define the process and how it will be implemented.
- Typically, a written process will be produced to compliment the PIMS formatting and validate against the Enterprise Management System (EMS). This document is likely to be in MS Word format, using Visio for process flow diagrams, or a format aligning to the EMS.
- The Assystem team will work with UKIFS
 Governance team to promote consistency across
 the Engineering Processes and clearly identify
 dependencies and linkages between the processes.
- The Assystem team for this task will be working alongside the Assystem PLM Change Management team will work closely, enabling alignment of objectives and information sharing between the parallel activities.
